ASRLMS invites Expression of Interest from qualified and experienced Chartered Accountants Firms for providing consultancy services for Financial Management and Technical Support.

Aajeevika - National Rural Livelihoods Mission (NRLM) was launched by the Ministry of Rural Development (MoRD), Government of India in June 2011. In November 2015, the program was renamed Deen Dayal Antayodaya Yojana (DAY-NRLM). Aided in part through investment support by the World Bank, the Mission aims at creating efficient and effective institutional platforms of the rural poor, enabling them to increase household income through sustainable livelihood enhancements and improved access to financial services. DAY-NRLM believes in harnessing the innate capabilities of the poor and complements them with capacities (information, knowledge, skills, tools, finance and collectivization) to participate in the growing economy of the country.

The Government of Assam has received a credit from International Development Association in various

currencies towards the cost of National Rural Livelihood Project through Govt. of India and intends to apply a part of the proceeds of this credit to payment under the contract for hiring a Consulting Firm for Financial Management and Technical Support Consultancy. The Consulting Firm will be selected in accordance with the Least Cost Selection Method set out in the NRLM Procurement Manual which follows the Consultant Selection Guidelines of the Work Bank Dated January 2011.

The Objectives of hiring Consultant for Financial Management and Technical Support Agency is to provide support to the Accounts Team of ASRLMS at SMMU, DMMUs and BMMUs in discharging responsibilities relating to financial management, Tally Synchronisation, preparation of Financial Reports, Taxation related matters of the Project implementation during the scale up and expansion phase.
