1. QUALIFICATION CRITERIA

2. TECHNICAL BID- COVER "A"

The bidder should furnish the following in a separate cover hereinafter called **"Cover A"**. *Court Fee Stamp of Rs 8.25 must be affixed*.

- a) Self Attested copy of Certificate of registration of the firm/company by the competent authority.
- b) Self Attested copies of Two (2) orders/contracts for construction & management of Exhibition/Fair/Event executed during the last three (3) financial years in State/Central Govt Sector/PSUs. The Completion Certificate should be furnished along with the order
- c) Undertaking as per **Annexure I.**
- d) Annual Turnover Statement of last 3 financial years from a Chartered Accountant/Auditor in the format at **Annexure II (With Audit Report of last three FY)**
- e) Self Attested copies of GST Registration certificate and PAN Card.
- f) The tender/bid document should be signed by the bidder in all pages with office seal and submitted with the bid.

3. PRICE BID - COVER "B"

Cover "B" shall contain the Price Bid of the bidder.

(i) Signature and Seal on each page

Each page of the price bid should be duly signed by the bidder affixing the office seal.

(ii) Rates quoted

The bidder shall submit the Price Bid (Cover – B) in the format at **Annexure-IV**. The rates quoted shall be inclusive of all taxes and any other charges. The component of Tax should also be shown separately.

The bidder shall put the duly signed Annexure-V in a sealed cover super scribed as "PRICE BID COVER "B" and addressed to the State Mission Director, Assam State Rural Livelihoods Mission Society (ASRLMS), Sivanath Gogoi Path, Panjabari, Guwahati-781037, Assam.

4. COVER FOR TECHNICAL BID & PRICE BID

The two separately sealed covers Technical Bid (Cover "A") and Price Bid (Cover "B")} shall be placed together inside a Single Cover which shall be sealed and super scribed as <u>NOTICE</u> <u>INVITING TENDER UNDER LIMITED TENDERING PROCESS FOR HIRING AGENCY FOR ORGANISING</u> <u>SARAS FAIR-2017</u> and addressed to the State Mission Director, Assam State Rural Livelihoods Mission Society (ASRLMS), Sivanath Gogoi Path, Panjabari, Guwahati-781037, Assam.

5. OPENING OF COVER "A" AND COVER "B" OF TENDER

- (a) Bidders or their authorized representatives are entitled to be present on the date and time of opening of Technical Bid Cover "A" and Financial Bid "Cover B". The Financial Bids of the Bidders who qualifies in the Technical evaluation stage would be considered for Financial Evaluation.
- 6. **Bid Price:** a) The Contract shall be for the whole works as described in the bill of quantities, technical specifications. Correction, if any shall be made by crossing out, initialing, dating and rewriting. c) All duties, taxes and other levies payable to the Contractor under the contract shall be included in the total price. c) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subjected to adjustment on any account.

7. VALIDITY OF BID:

Bids shall remain valid for acceptance for a period of 60 days after opening of Technical Bid i.e. Cover 'A'. Bids with shorter validity shall be rejected. Tender Inviting Authority may solicit bidders consent for an extension of validity period. A bidder may refuse extension request without forfeiting their EMD.

8. VALIDITY OF OFFER OF SUCCESSFUL BIDDER:

The validity of offer of the successful bidder shall be till completion of Event from the date of issuing order and the successful bidder will be bound to supply the items at the quoted rate without any changes. The maximum percentage by which work may be increased is: 15%.

9. Award of Contract:

(i) The Employer will award the contract to the Bidder whose quotation has been determined to be substantively responsive and who has offered the lowest evaluated quotation price and who meets the specified qualification criteria.

(ii) **Right to Reject Tender**

Tender Inviting Authority reserves the right to accept the tender or to reject the tender for all items or for any one or more of the items tendered at any point of time without assigning any reason.

(iii) Tender Acceptance

The acceptance of the tenders will be communicated to the successful bidder in writing.

10. NON ASSIGNMENT OR SUB- LETTING

The bidder shall not, at any time, assign, sub-let or make over the contract or the benefit thereof or any part thereof to any person or persons, whatsoever.

11. COMMUNICATION

All notices or communications relating to or arising out of the agreement or any of the terms thereof shall be considered duly served on or given to the bidder if delivered to him or left at his premises, places of business or abode.

12. ARBITRATION

Any dispute whatsoever in any way arising out of or relating to the contract shall be referred to arbitration of the State Mission Director, Assam State Rural Livelihoods Mission Society (ASRLMS), Sivanath Gogoi Path, Panjabari, Guwahati-781037, Assam or to the sole arbitration of some person nominated by him. The award of the arbitrator shall be final, conclusive and binding on all parties.

13. SAVING CLAUSE

No suit, prosecution or any legal proceedings shall lie against Tender Inviting Authority or any person for anything that is done in good faith or intended to be done in pursuance of tender. 14. **Opening of Bids**: Technical and Price Bid will be opened in the presence of bidders or their representatives who choose to attend on the date and time and at the place specified in the letter of invitation. Information relating to evaluation of quotations and recommendations for the award of contract shall not be disclosed to bidders or any other persons not officially concerned with the process until the award to the successful bidder is announced.

15. **Evaluation of Bids:** The Tender Issuing Authority will evaluate and compare the Bids determined to be substantially responsive i.e which (a) meet the qualification criteria specified in Qualification Criteria (b) are properly signed and Conforms to the terms and conditions, specifications. The Agency quoting the least price will be awarded the contract.
