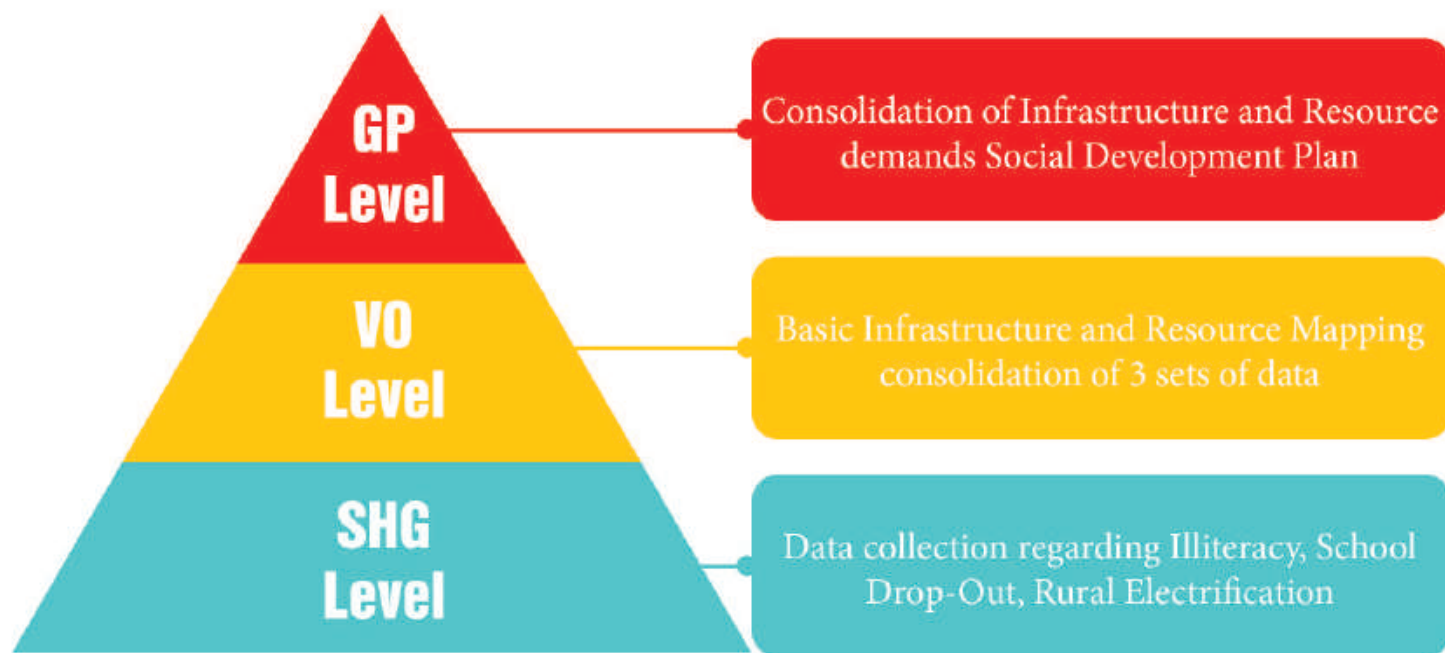

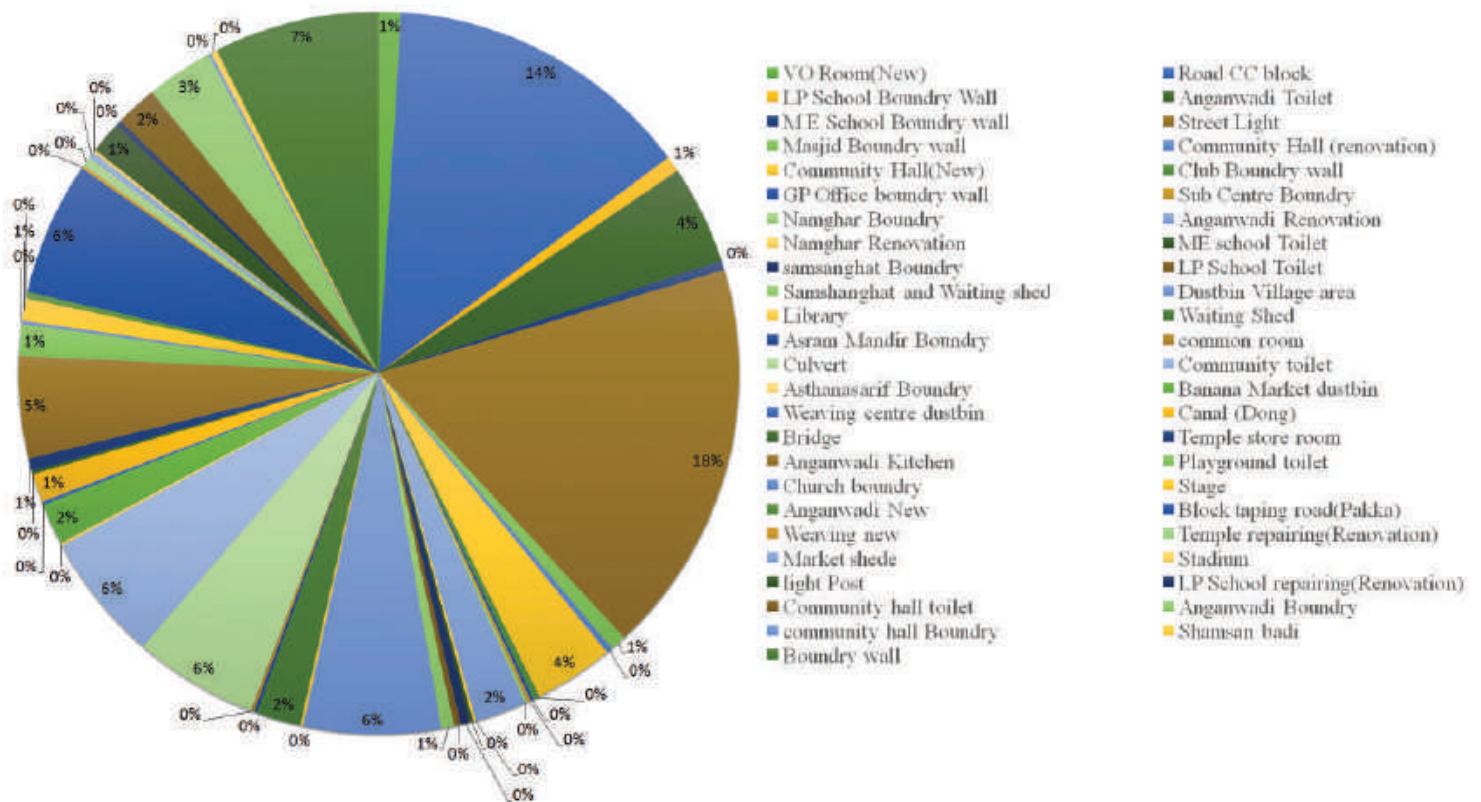

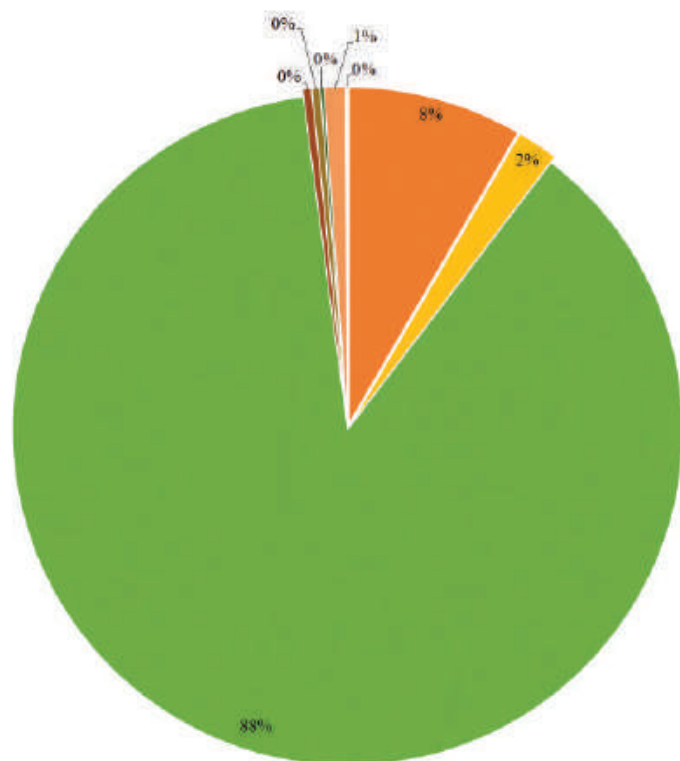

Examples of Proposal on Social Development - School Drop-out (1/3)

Participants

- SHG/VO wise quantitative data collection on school drop-out.
- Qualitative discussion with drop-out students, guardians and schools on the reason for drop-out.
- Awareness to the guardians of the student on what are the long term impacts of drop-out and how together with the community they can resolve it.
- Discussion and activation of School Management Committee.
- Re-enrolment in schools.
- Active involvement of CBO members and guardians in this committee
- Training on child labour/RTE for the existing cadres in the villages for awareness generation in the villages.
- Identification of resources for sponsorship and other needs of students.
- Identifying institutions for alternate education and long distance education
- Follow up on re-enroled students.

Examples of Proposals on Social Development - (2/3)



Project Area & Target Group:

The Project will be initiated in the Panchayats/VDC areas under which the Convergence Project is currently working and where illiterate women from SHG network are identified.

Target group will be the illiterate SHG women from the GPs/VDCs where PRI-CBO Convergence project is ongoing.

Beneficiaries of the Adult Literacy Project:

Beneficiaries are identified with the help of LRGs through SHG level survey.

Activities Planned:

- Identification of resource persons to take literacy classes.
- Training/Meeting with the resource persons identified.
- Development of teaching/learning materials for adult literacy.

To create awareness on the importance of education and drawbacks of child labour and absenteeism among cadres and the CBO:

- To train the LRGs on Child Labour and RTE.
- To generate awareness on the benefits of school education among guardians.
- To provide skills training and non-formal education to children with more than 4 years of gap in their schooling and improve their livelihood opportunities.

Challenges in Sixth Schedule Area - Karbi Anglong District

- Understanding of administrative structure.
- No specific guidelines on the process of rolling out GPDP in Sixth Schedule Areas.
- Limited trainers on VDCDP.
- Less active block level VDCDP Committees.
- Less clarity on funds available.
- Lack of official platform for decentralisation.



Impacts

- SHG network as the agency for consolidating the demands of poor.
- Acceptance of infrastructure and resource demands from VOs in all 78 GPs and 3 VDCs.
- Clarity on 'Low cost/No cost' plans under GPDP and incorporation of the proposals into the DSR by GP/VDC only in 73 GPs and 3 VDCs.
- Representation of 797 VOs in Gram Sabhas and using it as a democratic forum to present their demands.
- Capacity building of cadres and the SHG network through VPRP process.
- Panchayats readiness to conduct consultative meetings in 78 GPs and 3 VDCs.



Impacts in Sixth Schedule areas Karbi Anglong

- CBO structure internalised the process of participatory planning.
- Activation of the VDCDP facilitation committee in all 3 VDCs.
- Process aided in building rapport with the VDC Members, Block Staff and the CLF/VO members.
- Relationship building of CLF/VO with the Gaon Buras (Village Headmen).
- Women negotiated spaces for participation during the Mapping Process.

“Everyday Government comes up with new things. When VDCDP started, I had no idea how to do it. I was given training by SIRD but I was not clear on the process.
